This authorisation is for installation of a Low Voltage Single Phase Electricity Cable In, On, Across, Under or Over a Council Road/Footway.

Should this application be approved the following Standard Conditions will apply. Additional conditions may be applied.

1. A person (other than the Council or a person acting under some other statutory authority) must not make an alteration to a public road unless authorised to do so by the Council. Before any work is commenced the appropriate written authorisation for this proposal must be obtained from the Council Office.
2. An alteration is defined as:
 - The construction or arrangement of the road to permit or facilitate access from an adjacent property
 - The erection or installation of a structure (including pipes, wires, cables, fixtures, fittings and other objects) in, on, across, under or over the road.
 - Change or interference with or removal of a structures (including pipes, wires, cables, fixtures, fittings and other objects) associated with the road.
 - Planting a tree or other vegetation on the road, interfering with vegetation on the road or removing vegetation from the road.
3. Removal of any trees or native vegetation on a road/road reserve without prior Council approval is not permitted.
4. The applicant must not cause or unduly obstruct the use of the road.
5. The applicant must not cause or unduly interfere with the construction of the road.
6. The applicant must not cause or have an adverse effect on road safety. Appropriate road works signage must be erected during the duration of work involved in laying the pipeline on the road..
7. The cable is to be laid:
 - 750mm deep under the existing surface of a footway; and,
 - 1,000mm deep under the existing surface of a roadway; and,
 - be inserted in an orange coloured conduit, in accordance with Australian Standards.
8. Warning tape must be laid 200mm above the cable.
9. Cable to be laid between 400mm and 900mm from the property boundary and must be parallel to the boundary.
10. The cable must be laid at right angles - from the Pole to the 400mm - 900mm corridor, and from the corridor into the property.
11. The trench must be properly backfilled, consolidated and reinstated to the satisfaction of the Council's Director Works.
12. There is a possibility that other landowner/s have pipeline/cable buried on this road. Care should be taken not to disturb other pipelines/cables during the laying of your pipeline. Any approval granted by Council does not alleviate your obligation to abide by this advice. Council accept no liability for any

 14. This authorisation remains in force for a term of 42 years, and, at the expiration of that term, may be renewed by the Council for a further term fixed by the Council at the time of renewal.
 15. This authorisation is subject to revocation for breach of a condition.
