Section 74 of the Local Government Act 1999 sets out the actions which must be taken if a Member has a Material Conflict of Interest

Sections 74(5) of the *Local Government Act* provides that if a member of a council discloses a material conflict of interest in a matter to be discussed at a meeting of the council, then certain details must be recorded in the minutes of the meeting and on a website determined by the Chief Executive Officer.
