2022 PERIODICAL COUNCIL ELECTION RESULTS

At the close of nominations on Tuesday 6 September, the Electoral Commission of SA announced the names of the nominated candidates for the 2022 Council Elections.

As the number of candidates nominated to contest the election did not exceed the number of persons required to be elected in both the Telowie and Willochra Wards, all nominees were declared as **elected unopposed** (i.e. no election required) as follows:

Telowie Ward (3 required)

- » Phillip Heaslip
- » Stephen McCarthy
- » Sheriden Tate

Willochra Ward (4 required)

- » Lesley Till
- » Colin Nottle
- » Ian (Danny) Keller

The election result sees the return of four currently serving Council Members (Phillip Heaslip, Stephen McCarthy, Colin Nottle and Ian (Danny) Keller and two new members (Lesley Till and Sheriden Tate) joining Council.

The Electoral Commission of SA has confirmed that a supplementary election will be required in the near future to fill one vacancy in the Willochra Ward.

The Australian Local Government Womens' Association SA Branch promoted widely across the District to garner the interest of women to nominate and this appears to have had some influence in the outcome of the nominations and subsequent declaration of election unopposed.

Induction of the new Council will occur at its first Ordinary meeting on 29 November at 4.30pm.

Please note that following a review of internal controls, and in liaison with the Chair of Council's Audit & Risk Committee, a decision has been made to eliminate a risk pertaining to a current practice of allowing for payment of Council rates over the phone. We are currently investigating alternative cost effective options to enable on line payments and more information on this will follow in due course. The following existing options for payment of Council rates remain as follows:

1. In person at the Administration Centre, 3 Stuart Street, Melrose during normal office hours.
2. By cheque or money order.
3. Direct deposit / EFT (refer to bank account details on the rates notice and ensure you include the property Assessment number to identify what the payment is for).
4. BPAY.

We appreciate this change which comes into effect immediately may cause inconvenience for some people, however, on balance, the risk associated with the previous practice has been identified and assessed and the appropriate action taken is warranted and is in line with best practice.

2023 CITIZEN OF THE YEAR AWARDS – NOMINATIONS ARE OPEN

COUNCIL INITIATES COMMUNITY GROUP INSURANCE PROGRAM

At its August Ordinary Meeting, Council approved for the facilitation through its insurer (Local Government Community Insurance Services - JLT Risk Solutions Pty Ltd) for annual insurance coverage for nominated community and sporting groups based within the Council area (general public and products liability; personal accident-voluntary workers; Association Liability).

The annual insurance coverage has been secured for the nominated community groups and is valued at approximately \$1,200 for each of the groups which responded to Council's call for registrations of interest to partner with Council to secure a better deal for their communities through associated cost savings.

Council is pleased to partner with community groups and offer this cost effective insurance option at no direct cost to the nominated groups with the associated expenses being absorbed within Council's existing budget allocation for Council related insurances. It is hoped that groups value the generosity and contribution of Council.

WILLOWIE TRANSFER STATION PROJECT – SUCCESSFUL GRANT APPLICATION

The Hon Susan Close MP, Minister for Climate, Environment & Water has confirmed that Council was successful in its application for grant funding totalling \$183,154 for the Willowie Transfer Station project.

Willowie is the current site for Council's only waste facility, servicing nine townships and a population of 3000 people over an area of 3400 sq kms. It is a landfill site without capacity for separating waste and removing recyclable items such as plastics, glass, timber, cardboards and paper. The Mount Remarkable Waste Management Project will construct a Waste Transfer Station at Willowie that will meet current EPA guidelines and enable 98% of all material being deposited at the site to be recycled including 100% of general waste, recyclables, and green waste.

The funding received enables for the construction of a Waste Transfer Station at Willowie with a 12m x 30m building comprising steel columns, concrete walls and solid roof to meet current EPA guidelines. Once completed and operational it will enable 98% of all material being deposited at the site to be recycled including 100% of general waste, recyclables, and green waste.

Council is committed to reducing waste to landfill, increasing resource recovery, and improving community knowledge of responsible waste management practices. To achieve this, improvements to recycling



practices and minimising landfill is required. This project is needed as there is no material recycling facility at the District's only waste facility at Willowie.

Willowie is designated as a landfill site and to minimise sending waste to landfill, Council has sought and received development approval to convert the landfill site to a waste transfer station. Council's responsible waste management and resource recovery objectives are built on the principles of ecologically sustainable development and the waste management hierarchy outlined by GISA".

The new facility will be opening for use sometime in October 2022.

NEW ADMINISTRATION STAFF MEMBER

DOG AND CAT REGISTRATION RENEWAL PERIOD

The Council undertook a massive challenge of improving its rankings as one of the leaders in Dog Registrations in South Australia.

Barunga West Council topped the list with 95.44% of dog registrations completed. Closely followed by their best competition Kimba who placed 2nd for the third year in a row and a round of applause for DC Mount Remarkable who decided to go like the clappers and came in 3rd place getting over 90% renewed for the first time.

Overall in the state Dog Registrations are at 72.09% (74.17% same time last year and the Dog & Cat Board were at 78.79% in 2020/21) renewed at the **ANIMAL** level with 45 councils above the average and the remaining 24 below the average. The Dog & Cat Board remind Councils that every year we finish the **FINANCIAL** year with roughly 8% that do not renew. Typically, the Dog & Cat Board finish at this 70-80% renewed and then get another 10% renewed by the time all councils have applied late fees and the final 10% pay after mid-October.

The District Council Mount Remarkable saw the highest renewal increase out of all the 68 Councils throughout South Australia with a 19.9% increase in renews as of 30 August 2022.

With the growing interest in the emergency animal disease (EAD) threat to Australia, primarily due to foot and mouth disease (FMD) and lumpy skin disease (LSD). There are a number of courses that have been created by Animal Health Australia and looks at EAD preparedness, response arrangements and biosecurity in general.

The EAD Foundation course provides a good baseline for anyone that has an interest or has the potential to be asked to provide support to PIRSA. The FMD Awareness course provides information about the risk, how to help prevent it, and what would happen if an FMD outbreak occurs.

South Australian Drought Resilience Adoption & Innovation Hub

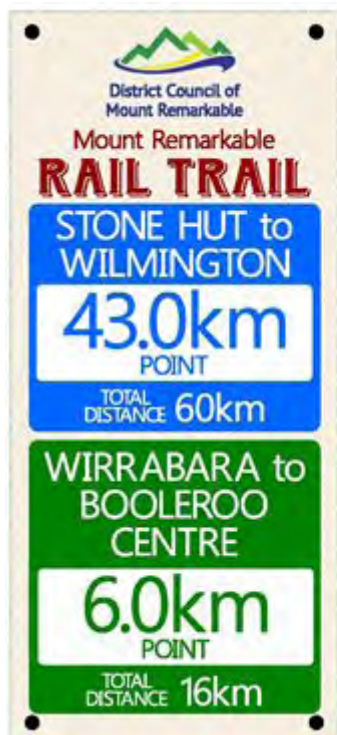
The SA Drought Hub is an exciting initiative which brings together a dynamic network of primary producers, industry groups, researchers, government agencies, universities, agribusinesses, traditional owners, and others to work towards a common vision to strengthen the drought resilience and preparedness of our farms and regional communities in South Australia.

The SA Drought Hub is one of eight established across the nation through the Australian Government's Future Drought Fund. Led by the University of Adelaide in partnership with the Department of Primary Industries and Regions (PIRSA), the SA Drought Hub comprises the Hub headquarters at Roseworthy and five regional nodes at Minnipa on Eyre Peninsula, Port Augusta in the Far North, Orroroo in the Upper North, Loxton in the Riverland, and Struan in the South-East.

The location of the nodes ensures state-wide coverage of all pastoral, low, medium and high rainfall agricultural production zones. <https://sadroughthub.com.au/>

The steps to increased drought resilience

- » **Collaboration** - With input from the relevant partners and other local community members, regional drought resilience priorities will be identified.
- » **Regional action** - Activities will be co-designed at a regional level and driven from the ground-up.
- » **Creating change** - Bespoke extension programs will be implemented to facilitate adoption of drought resilience practices and strategies in our farming systems and regional communities.



REMARKABLE RAIL TRAIL

The “Remarkable” Rail Trail from Booleroo Centre to Stone Hut is nearing completion. Sections of the trail were damaged in the recent rain events and those repairs will be occurring soon.

Placement of concrete culverts, signage and some remaining material placement will be occurring over the next few weeks. Bridge placement in four (4) locations is progressing slowly due to material and contractual arrangements, but hopefully these will be finalised by the end of November 2022.

This will open up the trail from Wilmington in the north to Stone Hut in the south, passing through townships of Melrose, Booleroo Centre and Wirrabara along the way. This equates to a total of trails through the Council area totalling over 66km.

BOOLEROO AIRSTRIP FENCING UPGRADE – FUNDING

The Booleroo Centre Airstrip has received \$50,000 in funding to replace fencing at the site. The funding has been received as part of the “Support Regional Aviation Program Round 7” from the Department for Infrastructure & Transport (DIT). The grant covers 43% of the total cost (estimated at \$116,000 EX GST).

The Booleroo Centre aerodrome is a significant and vital Council and community asset and the only aerodrome in the District. This Safety Project will increase aviation safety and accessibility of the Airstrip by the Royal Flying Doctor Service, emergency services and comply with the Civil Aviation Safety Authority (CASA) regulatory requirements. The project will ensure the safety of the operators, aircraft owners and passengers is increased, and that aircraft infrastructure is not damaged through collisions between animals and aircraft. It will also increase the quality and range of services provided to the Mid North region and will ensure that residents of the region that they are not disadvantaged or excluded from vital emergency services because of inferior infrastructure.

Airstrips are essential infrastructure assets to regional Australia. They provide connectivity, social equity and contribute to their surrounding economy. The Booleroo Centre Airstrip is vital transport infrastructure for the Mid North Region and is used by the Royal Flying Doctor Service (RFDS) on a monthly basis as well used by emergency services for fire fighting/water bombing activities, aerial spraying, air freight, business visitors including agribusiness, tourists as well as recreational flying and general

aviation users. Importantly, the upgrades to the aerodrome will enable safe, 24 hour delivery of RFDS and other emergency services to the Booleroo Centre and broader Mid North community. Booleroo Centre Airstrip consists of a single runway layout of 18m in length and is constructed from a course natural gravel. It is recommended that the new fencing upgrade be carried out to ensure future compliance.

The Booleroo Centre Airstrip Safety Project will upgrade the boundary fencing to ensure kangaroos, wallabies, wombats and other large animals cannot access the runway area. The fencing upgrades outlined below will increase the aviation safety and accessibility of the Airstrip to current and new users. These upgrades will not only ensure that these vital emergency services continue, but the safety of the operators, aircraft owners and passengers is increased, and that aircraft infrastructure is not damaged through poor visibility.





FIRE DANGER RATING

The Fire Danger Rating is an indicator of how dangerous a bushfire could be if it did occur. It is not a predictor of how likely a bushfire is to occur. It should be used as an early indicator to trigger your plans. You need to understand the Fire Danger Rating to help you assess your level of bushfire risk and to decide what actions to take. The Bureau of Meteorology forecasts the rating each day. The higher the Fire Danger Rating, the more dangerous the fire conditions.

The Fire Danger Rating will help you understand the predicted bushfire behaviour, potential impacts and recommended actions you should take for each category level. We recommend you take the time to review and understand the ratings. Remember:

- » Fires can threaten suddenly and without warning
- » Watch for signs of fire, especially smoke and flames



- » Know the Fire Danger Rating in your area for the day, be aware of local conditions and keep informed
- » Have your Bushfire Survival Plan and kit ready

- » Call **000** to report a fire
- » To find out more listen to local radio,
